AUCTION NOTICE

An open auction for 5300 Kg (Approx) Raddi having Assignment and HBIs, scrap Paper including old prospectus of B.Ed, Mid-Term Paper, Unused question paper and envelops of question papers etc. lying in various Departments/offices/branches in this University are to be auctioned through open auction on **13.10.2023 at 11:00 AM** in the committee Hall on the aforesaid date & time. For details and other terms and conditions of this action is as under:

Terms and conditions:

1. The vendor/offeree will have to deposit identity i.e. copy of Aadhar Card/Pan Card/Voter Card etc.
2. The auction of Raddi offer will start at minimum rate of Rs.14/- per kg. and above.
3. The University is auctioning Raddi having Answer Books, Noting & Letters and papers etc. and therefore, the Vendor/offeree will use the same as Raddi and shall not misuse the Assignment and HBIs, scrap Paper including old prospectus of B.Ed, Mid-Term Paper, Unused question paper and envelops of question papers etc. of the University after lifting of Raddi.
4. Each vendor/offeree will have to deposit refundable security of Rs.10,000/- (in case) at the time of Auction, which shall be refunded at the end of auction. However, the security of successful (Highest offerer) shall be deposited in University Main Account and will be adjusted in the total offered cost/price.
5. The Raddi will be disposed off on "as is where is" basis. The Raddi can be inspected seen on working days during hours (10.00 A.M. to 4.00 P.M.) by contacting the Estate Officer, General Branch, CDLU, Sirsa.
6. The highest vendor/offeree has to make 100% payment of total offered cost price at the time of auction (after declaration of highest vendor/offeree). The payment will be accepted in the shape of demand draft drawn in the favour of the Registrar, CDLU, Sirsa payable at Sirsa OR payment can be deposited at university cash counter.
7. No complaint about the quantity, quality or condition of the Raddi will be entertained after the auction. The Raddi would be handed over to the highest vendor/offeree on "as is where is" basis. The University shall not be responsible of their use fullness or quality.
8. The rights to accept or reject the highest offer finally vests in the Vice-Chancellor of the CDLU, Sirsa.
9. In case of any dispute, the decision of the Vice-Chancellor of the CDLU, Sirsa will be final and binding.

10. The highest vendor/offerer shall make his own arrangements for transportations loading Unloading and permit etc. if required after acceptance of his/her bid. The vendor/offerer shall have to pay the local taxes, surcharge or any other tax with the concerned authorities, in addition to the amount offered.
11. The Raddi will have to be lifted by the highest vendor/offerer with in one month after acceptance of the highest bid. Loading and lifting of the auctioned Raddi shall be done by the purchaser only during the prescribed working hours of the CDLU, Sirsa. No deliveries shall be affected during Sunday or Holidays.
12. In case the highest vendor/offerer is unable to lift the Raddi in specified period after acceptance of the highest bid, the total amount deposited alongwith the security money deposit shall be forfeited by the University and re-auction will be conducted.
13. Highest vendor/offerer will be responsible for any damage done to the University by his/her labour directly or indirectly at the time of lifting the Raddi.
14. The quantity of 5300 kg. (approx.) Raddi lying at different place/offices of University and this quantity may increase/decrease on actual weighment.
15. If, sufficient vendor/offerer so not participate, in the auction, the Vice-Chancellor of the CDLU, Sirsa reserves the right to re-auction the Raddi.
