

MEMORANDUM OF UNDERSTANDING

Jan Nayak Foundation, Pehowa, Kurukshetra, Haryana- 136119 hereafter referred to as of the first party

AND

Chaudhary Devi Lal University, Barnala Road, Sirsa, Haryana- 125055 hereafter referred to as of the second party

Jan Nayak Foundation and Chaudhary Devi Lal University, Sirsa are individually referred to as first party and second party and collectively as the parties.

Whereas

1. That Jan Nayak Foundation is a registered company incorporated under the Companies Act by the Central Registration Centre in the Ministry of Corporate Affairs, Government of India with Corporate Identity Number U85100HR2022NPL100893 dated 29.01.2022. It is established with the aim to help, develop, facilitate, promote, support the people and their families especially in the field of education, social justice, to enhance skill &

- opportunity by providing coordination and training, to provide over all assistance to poor students, men, women in cities/town/villages of India in general and primarily to those students who are enrolled in the second party to undertake promote and award research study, conducting training and excellence, to establish, setup, maintain, preserve, run in any part of India schools, colleges, centre for personal and professional growth of enrolled students etc. as detailed in the MoU of the first party (copy attached).
2. That Chaudhary Devi Lal University, Sirsa is a body corporate duly established by the Haryana Government under State Legislature Act no. 9 of the 2003 with aim to establish and incorporate a (teaching-cum-affiliated University) at Sirsa to facilitate and promote higher education. The University is imparting education to the students by way of on campus departments/centres and affiliated colleges.
 3. Jan Nayak Foundation is keen to provide over all assistance to the poor students, men, women of the second party as per its MoU and rules.
 4. Second party (CDLU) desires to act in collaboration with the first party for providing all over assistance to the poor students, men, women of the second party.

Now, therefore, in consideration of the mutual promises set forth herein, the sufficiency of which is hereby acknowledged, the Parties hereby agree to enter into this MoU as follows:

SCOPE

This MoU intends to establish a collaboration/understanding between the parties for providing over all assistance to the poor students, men, women of the second party as per the MoU and rules of first party.

GOVERNANCE

The MoU is to be governed by the rules, regulations, ordinance, MoU of first and second party alongwith changes/amendments from time to time.

RESPONSIBILITY

Responsibilities of first party (Jan Nayak Foundation)

1. The first party will provide assistance to the students, men, women of the second party as per its MoU and rules without any consideration from the stakeholders or the second party.
2. The first party will arrange, provide assistance in any form to the students, men, women of the second party at its own as per its MoU and rules.

3. The arrangement for assistance will be the first party at its own.
4. The first party will consider the names of the students, men, women as provided by the second party for over all assistance as per its MoU and rules.
5. The first party will provide assistance solely at its own and do the needful.

Responsibilities of second party

1. The second party will provide the names of the needy students, men, women to the first party for consideration for providing assistance.
2. The second party will provide the names, detail and assistance required for consideration for assistance to the second party.
3. The second party will provide the names in term of its rule, regulations.
4. The second party will coordinate and cooperate to the first party in consideration for assistance by way of support, detail of data, requirements, rules etc..
5. The second party will cooperate and coordinate to the first party, to the students, men, women of second party in getting and extending the overall assistance from and by the first party and do the needful.

Limitation/Miscellaneous

This MoU is a mutual understanding/collaboration just to provide assistance to the students, men, women of the second party by the first party without consideration from either party and will effective from the date of signing by the parties and shall remain in operation until revoked by the either party by the way of 03 months prior written notice to the other party but with effect from prospective academic session and on-going assistance/requirements will be completed. The MoU will be subject to the norms of first & second part and will effective until it is in compliance of the norms. The changes in the norms will be deemed part of this MoU and its effect. The acts of force measures will not create any liability to any party. The MoU is an agreement/mutual understanding/collaboration of the parties for the increase of credibility and goodwill and will work on the cooperation and coordination upto the extent of liabilities. Amendment, change, modification, alteration, if any, in this MoU will be on mutual consent of the parties and in written.

Residuary/Jurisdiction/Interpretation

The meaning of the word, paras and expression used in this MoU shall be considered in the context of the meanings used in the relevant rules/guidelines of first and second party. The meanings expressed in the relevant rules/guidelines will prevail. The Jurisdiction will be of Sirsa court in all matters relating to this MoU exclusively Dispute if any on account of this MoU will be referred to the sole arbitrator to be appointed by mutual consent of both the parties.
