 - III Coordinator of each CLUB (Coordinator shall be nominated by the Vice-Chancellor on the recommendations of the Dean Students' Welfare)
 - IV Coordinator, NSS
 - V Coordinator, Youth Red Cross
 - VI Director, Youth WelfareFifty percent members shall form the quorum.
3. The aims and objectives of the CLUBS:

To be proposed by the concerned coordinator and seconded by the Executive Committee.
4. The expenditure will be incurred from the Amalgamated Fund on any activity duly approved by the Executive Committee.
5. The office of the Dean Students' Welfare shall be the executive office for all the CLUBS.
6. The Coordinator concerned shall work as a Member-Secretary of the respective Club.
7. Annual report of the working of the Club during the Academic year shall be prepared by the Member-Secretary and presented to the Executive Committee for its approval.
8. At least one meeting of the Executive Committee shall be convened in one Semester.


