At the outset, the Vice-Chancellor welcomed the members, new Government Nominee Dr Sandeep Kumar Goel and officiating Registrar and Ex-officio Member Secretary of the Academic Council. Thereafter, the agenda was taken up as follows:

1. Confirmed the minutes of 27th meeting of the Academic Council held on 19.09.2020, The follow up actions on Resolution No. 20 of the 26th meeting of Academic Council held on 12.06.2020 was also confirmed as action has been taken by R&S Branch as conveyed vide endst. No. R&S/2021/1184-87 dated 20.04.2021.
On resolution No. 6 of the 27th meeting of the Academic Council held on 19.09.2020, the validation period of GATE for 4 years was considered for eligibility of admission in Ph.D. Course.
2. Noted the action taken report on the decisions of the previous meeting of the Academic Council held on 19.09.2020.
3. Noted the action taken by the Vice Chancellor under Section 11(6) of the University Act, 2003 regarding approval of the Scheme and Syllabus of Ph. D course work for

Education and Physical Education w.e.f. Session 2020-21 with change in the nomenclature of course work in the department of Physical Education from Pre-PhD course work to Ph.D. course work.

20. Considered and approved the recommendations of the Departmental Research Committee, PGBOS&R in English and Faculty of Humanities in respect of the Ms. Shilpa Rani D/o Sh. Hari Chand (Regn. No. 2018035500174724) scholar for registration in Ph.D. program in Dept. of English- 2018-19.
21. Considered and approved the amendments in the Ordinance of CBCS for PG programs as under:

2. The University Teaching Departments/Colleges will make an arrangement through some digital platform for offering such courses.
3. The Chairpersons emphasized the need for adopting tutorial period which will be undertaken in each Core Course and Core Elective Courses and will be strictly in accordance with the UGC norms.
22. Considered and approved the modalities regarding opting of Massive Open Online Courses (MOOCs).

Many PG and UG Massive Open Online Courses are available on SWAYAM portal and academic resolved to adopt all courses available on SWAYAM portal. The Academic Council also resolved that MOOCs courses can be offered as Core Courses or /and Open Elective Courses and the percentage of such courses can be up to 40% of the total credits of a particular degree in accordance with UGC Guidelines. However, it will not be mandatory rather optional for the university.

The detailed modalities of MOOCs are as under:

1. List of MOOCs available on SWAYAM portal stands approved by Academic Council.
2. Every Department will appoint a MOOCs Coordinator.
3. MOOCs coordinator will identify the courses from the list and motivate the students to opt MOOCs courses from the list as approved by Staff Council/Academic Council.
4. A student can opt MOOCs courses may be up to 40 percent of their degree credit hours.

5. These 40 percent of the courses include Core Courses or Open Elective Courses.
6. The student will submit the MOOC's certificate after passing the particular course to the Department MOOC Coordinator/ Chairperson who will submit those certificates to the Controller of Examination (COE) through the MOOC Convenor appointed by the University for regulating the MOOC/Online Courses related affairs.
7. The Controller of Examinations will incorporate the credits earned by the student in his/her Detailed Marks Certificate.
8. The Controller of Examinations shall ensure the inclusion of the MOOC's award in the DMC/Degree of the concerned students.

On the suggestion of Prof Priyanka Siwach it was further resolved to request the Dean Academic Affairs to prepare a comprehensive draft of these guidelines and get it circulated in all departments after getting the same approved from the Vice Chancellor.

23. Considered and approved the request of the Research Scholar Ms. Arkin Chawla, Regn. No. 15155740002 to pre-pone the submission of her revised thesis and it was resolved to allow the candidate to re-submit the thesis almost after four months that is after the resolution passed by the academic council instead of following the rule of not earlier than six months and not later than one year in case of resubmission. It was resolved to not make it as a precedence.
24. Considered and approved the minutes of the meeting held on 02.09.20, 13.10.20, 06.11.20, 07.01.21 and 25.01.21 for framing University's policy on 'Academic Integrity and Prevention of Plagiarism' and it was decided to keep the permissive level of similarity index to 20 percent. It is resolved to change the name of the plagiarism software given in the document from URKUND to OURIGINAL. Also resolved to correct the name of the Faculty of Management, as given in the minutes of the committee constituted to frame the plagiarism policy, to Commerce and Management.
Further resolved to note in the minutes the appreciation extended by the house to the then Dean Research and the committee members for creating a wonderful draft of the Plagiarism Policy.
25. Considered and approved the recommendations of Dean Research and Dean Academic Affairs for grant of extension to Ms. Megha, (Regn. No. 124575005) Research Scholar, Department of Biotechnology for submission of Ph.D. thesis up to 08 years from the date of Registration i.e. 25.03.2014.
26. Considered and approved the proposal for introduction of new courses from the Academic Session 2021-22 according to "Vision Beyond 2020-21" and also approved the request to be made to the State Government to sanction proposed teaching and non-teaching posts and required physical infrastructure as detailed in the Vision Beyond 2020-21 documents.
Further, it is resolved to refer this matter to the Executive Council for creation of Teaching and Non-teaching posts/related necessary actions.
27. Noted the action taken by the Vice-Chancellor under Section 11(6) of the University Act, 2003, with regard to approval of the Annual Quality Assurance Report (AQAR)

30. Considered and approved the recommendations of the Departmental Research Committee, PGBOS&R in Law and Faculty of Law in respect of Ms. Jyotsana Choudhary D/o Sh. Govind Ram Choudhary (Regn. No. 2018035500174465) for registration in the Ph.D. program in Dept. of Law - 2018-19.
31. Considered and approved the guidelines of Ministry of Social Justice and Empowerment department of Empowerment of persons with disabilities, New Delhi issued vide O.M. No. 3402/2015-DD/III dated 29.08.2018 and further circulated by the Secretary, University Grants Commission vide F.No. 6-2/2013(SCT) dated 14.01.2019 to the Registrars, all Universities/deemed to be Universities for conducting written examinations for person with benchmark disabilities.

Considered and approved that the CA/CS/ICWA qualifications be treated equivalent to PG Degree on the basis of Public Notice, issued by the Secretary, University Grants Commission, New Delhi vide No. D.O. No.9-35/2016 (CPP-II) dated 15th April 2021 for admissions in the courses run under the Faculty of Commerce and Management.

- i) Considered and approved the Panel of Subject Experts for selection of teachers as recommended by the Staff Councils of University Teaching Departments. Further, the Academic Council resolved to authorize the Vice Chancellor to include sufficient names of SC and Women experts in the panels before sending the panels to the Chancellor of the University for approval.

- iii) Noted the action taken by the Vice Chancellor under section 11(6) of the University Act 2003 for grant of approval of Hand Book of Information for M.Ed. Programme (Regular) for the Session 2020-21.
- iv) Considered the objections on the result of B.Ed. 1st year prepared on 100% evaluation on the basis of internal evaluation as the case is of annual pattern of examinations and resolved to authorize the Vice Chancellor to constitute a committee to look into the matter.
- v) Considered the case of award of URS to scholars and resolved not to award any URS from this day onward even if recommendation of department is pending because of subjective contents appearing in such recommendations and constitute a committee comprising the following to frame policy in this regard:
 - a) Dean Academic Affairs
 - b) Dean Research
 - c) Two more members to be nominated by the Vice Chancellor.
- vi) Considered and authorized the Vice Chancellor to constitute a committee to reframe Ph.D. admission Guidelines/Ordinance with strict compliance of UGC Ordinance and other norms.
- vii) On the suggestion of the Higher Education Commissioner nominee Mr. Sandeep Kumar Goyal, Principal, GNC, Sirsa, the house resolved to authorize the Vice Chancellor to constitute a committee for looking into the matter of evolving a uniform system for practical examination for all undergraduate courses.
