Mrs. Suman Raghuvanshi, Under Secretary (Finance) attended the meeting as a representative of the Financial Commissioner & Principal Secretary to Government, Haryana, Finance Department.

At the start of the meeting, the Vice-Chancellor welcomed the members to the 29th meeting (Emergent) of the Executive Council. Certain members desired that only the recommendations of the Finance Committee Meeting held on that very day at 11.00 a.m. in the office of Financial Commissioner & Principal Secretary to Govt. Haryana, Finance Department, Chandigarh may be discussed for approval.

1. **Confirmed** the minutes of the 28th meeting of the Executive Council held on 26.03.2009 circulated vide letter No. CDLU/Acad./EC/124/09/2001-19 dated 28.03.2009.
2. **Noted** the follow up action on the decisions taken in the previous meeting held on 28.03.2009.
- 3.-15. The items were deferred for consideration in the next meeting
16. Considered the recommendations of the Finance Committee made in its meeting held on 29.06.2009 at 11.00 a.m. that the Budget Estimate of the University for the Financial Year 2009-10 be approved with the following stipulations :
 - i) The University may write to Higher Education Commissioner, Haryana for making provision under Non-Plan also, from the financial year 2009-10 onwards for salaries and other recurring expenditure instead of releasing grant only under Plan head.

- ii) Efforts should be made by the University to increase atleast 200 seats in Science, Commerce and Economics during the current financial year and this trend may be continued for the years to come.
- iii) As there are no plans/provisions for expansion of the University in the budget presented for the year 2009-10, so it was proposed that the University should make efforts to start Honours Courses in Science Subjects at undergraduate level and the State Govt. be approached for sanctioning additional posts of lecturers and also simultaneously for providing additional grant to this effect including infrastructure.
- iv) The University may put its proposal for allocation of additional funds at the time of submitting revised estimates during August/ September to the Administrative Department and Finance Department respectively.
- v) As B.Tech. courses are already in existence at Ch. Devi Lal Memorial Engineering College, Panniwala Mota, so similar B.Tech. Courses may not be started in the University campus as proposed in the budget to avoid duplicity.

RESOLVED that the above recommendations of the Finance Committee be referred to the Court for approval.
