4. Noted the follow up action on the decisions taken in the 46<sup>th</sup> meeting of the Executive Council held on 31.03.2014.
5. Considered and approved the revised Balance Sheet on the Accounts of Chaudhary Devi Lal University, Sirsa for the financial year 2012-2013.
6. Considered the Annual Report of Chaudhary Devi Lal University, Sirsa, for the calendar year 2014.

RESOLVED to recommend the Annual Report 2014 to the Court for approval.

7. Considered the recommendations of the Finance Committee made vide Resolution No. 3 of its meeting held on 30.03.2015 with regard to the Budget Estimates of Chaudhary Devi Lal University, Sirsa for the Financial Year 2015-16 and Revised Budget Estimates for the Financial Year 2014-15 with the stipulations that:

- (i) The proposed expenditure for 2015-2016 be restricted to available resources (i.e. Grant-in-aid of Rs. 4000.00 Lacs from State Government, internal income of the University, Grants from U.G.C. & other Funding Agencies as well as the balance available with the University as on 01.04.2015). However, proposed recurring expenditure (except salary) for 2015-2016 under Main Budget be reduced by cut of 10 % i.e. Rs. 179.83 Lacs (3660.54-1862.24) and Budget Estimates for the next Financial Year 2016-2017 be prepared under Capital and Revenue Heads instead of Plan & Non-Plan Heads.

RESOLVED to recommend the above recommendations of the Finance Committee to the Court for approval.

Resolution No. 5 of its meeting held on 30.03.2015 with regard to the Balance Sheet on the Accounts of Chaudhary Devi Lal University, Sirsa for the financial year 2013-2014:
