




The Committee after going through all the relevant record recommends as under:

1. There are 126 total sanctioned regular teaching posts in the University. As per instructions of the Government, 10% of the sanctioned posts in addition to above can also be filled up by the Assistant Professors (Contract). As such 12 posts can be filled up in addition to 126 sanctioned posts i.e. 138 posts are available. Only 61 posts have been filled up by regular teachers and $65+12=77$ posts can be filled up by adjustment of Assistant Professors (Contract). A list of the Assistant Professors (Contract) is attached at Annexure-I.
2. Accordingly, all the 74 Assistant Professors (Contract) working in the University can be paid Rs. 57,700/- as monthly remuneration against the vacant sanctioned posts. However, as and when the vacant sanctioned posts in any department are filled up by regular appointment, the Assistant Professors (Contract) engaged against such filled up sanctioned post(s) will have to go on the basis of last come first go rule.
3. In case workload of any particular Assistant Professor (Contract) in any department has less than 16 hours and the same workload is available in any other department, his/her workload may be completed by assigning the workload, if available from other department. Further, if any Assistant Professor (Contract) not completed 16 hours workload, he/she may be paid remuneration as per existing University rules.
