Recommendations submitted by the delegation after visiting Universities of Indonesia:

- i) The representatives of CDLU, Sirsa and Undiksha presented their Power Point Presentations before the members of both the Universities. Thereafter, a detailed discussion was held with the authorities and faculties of Universitas Pendidikan, Ganesha (Undiksha), Bali, Indonesia and an MoU was signed by the Registrar, CDLU, Sirsa and the Vice-Rector, Undiksha, Indonesia.
- ii) The following departments were identified by Undiksha, Indonesia for future collaboration:
 1. **Faculty of Physical Sciences** (Department of Chemistry & Department of Mathematics)
 2. **Faculty of Social Sciences** (Department of Geography)
 3. **Faculty of Law** (Department of Law)
 4. **Faculty of Education** (Department of Physical Education and Department of Education)
 5. **Faculty of Commerce & Management** (Department of Commerce)
 6. **Faculty of Engineering & Technology** (Department of Computer Science and Engineering and Food Science and Technology)
- iii) The delegation visited university of Pamulang for deliberation with other universities also where university presentation was made and discussion was held for future collaboration with the invited universities. The list of the Universities is as under:
 - a) Universitas Muhammadiyah Tangerang
 - b) Universitas Banten Jaya, Banten
 - c) Universitas Islam Syekh Yusuf
 - d) Universitas Pamulang
 - e) Universitas Sutomo

The delegation invited the faculty of above mentioned universities to enroll in Ph.D. program at CDLU, Sirsa. During discussion, all the universities raised the issue of concession in tuition fee or some kind of scholarship to pay for their sustenance at CDLU, Sirsa.

Following are the recommendations of the delegation:

- i) The Competent Authority may provide partial tuition fee waiver in admission and hostel fees to the Indonesian students on case to case basis opting for admission in

various programmes (recommended by the universities having MoU with CDLU, Sirsa).

- ii) The credit requirements for Ph.D. course work may be allowed to earn through UGC recognized online courses as per Clause 9 (1) of UGC Minimum Standards and Procedures for Award of Ph.D. Degree Regulations, 2022.
- iii) The faculty of the Indonesian University may be allowed to co-supervise the prospective Indonesian Ph.D. scholars.
- iv) The Ph.D. scholars who opt for Ph.D. (part-time mode) may be allowed to present their progress seminars in online mode.
- v) The University Teaching Departments of CDLU, Sirsa identified by the Undiksha may be allowed to proceed further for mutual academic collaboration.
- vi) The credit transfer may be allowed to the students of Indonesian Universities who are willing to pursue course work in various programmes for one semester.
- vii) Internship programme may be offered to the Indonesian students.
- viii) Joint conferences may be organized in blended mode.
- ix) The visiting faculty from Indonesian universities having MoU with CDLU, Sirsa may be allowed a free accommodation in the Faculty House for a maximum period of one month.
- x) The delegation found utmost discipline on the Bali island as far as traffic movement was concerned. The delegation recommends a value added course in traffic discipline to the students of CDLU, Sirsa and make it mandatory to earn the degree.
- xi) The faculty of this University may be allowed to deliver invited lectures through online mode at various Indonesian Universities as and when invited and vice-versa.
- xii) The students of CDLU, Sirsa may be allowed to visit Indonesia for various cultural exchange programmes.
- xiii) Indian Council for Cultural Relations (ICCR) offers scholarships for international students to study in India. Therefore, the link of ICCR and other websites may be shared with the partner universities.
