**MINUTES OF 65<sup>TH</sup> MEETING OF THE EXECUTIVE COUNCIL HELD  
ON 13.11.2021 AT 11.30 A.M. THROUGH BLENDED MODE.**

At the outset, the Vice-Chancellor welcomed the Members of the Executive Council. As Dr. Rakesh Wadhwa, Registrar was not available, the house decided to appoint Sh. Kuldip Kumar, Deputy Registrar to act as Secretary for this meeting. Thereafter, the agenda was taken up:

1. Confirmed the minutes of 64<sup>th</sup> meeting of the Executive Council held on 03.08.2021 and reviewed the resolution nos. 11, 26, 27, 28 & 30. Further, the Resolution No. 35(ix) was approved as under:  
  
35(ix) Considered and approved the correction in the earlier Resolution no. 35(ix) of the above meeting to waive off the Room Rent charges in respect of students of Girls and Boys Hostels due to Covid-19. The period for which the room rent charges have been waived off, will be for four months w.e.f. 19.03.2020 onwards for the session 2019-20 and from 15<sup>th</sup> April, 2021 to 28.06.2021 for the academic session 2020-21, instead of 2020-21 as mentioned in the earlier resolution.
2. Noted the follow up action on the decisions taken in 64<sup>th</sup> meeting of Executive Council held on 03.08.2021.
3. Noted the action taken by the Vice Chancellor under section 23(4) of University Statutes for Engagement of Sh. A.K. Modi, (Retd.) Chief Engineer, PWD B&R as Technical Advisor for a term w.e.f. 23.08.2021 to 22.02.2022.
4. Noted the action taken by the Vice Chancellor under section 23(4) of University Statutes for Extension in Engagement of Sh. Himmat Singh, Security Consultant for a term w.e.f. 20.09.2021 to 19.03.2022.
5. Considered and approved the recommendations of the Committee dated 11.10.2021 constituted by the Vice-Chancellor to look into the matter regarding change of nomenclature for the post of Pharmacist to Pharmacy Officer in terms of Haryana Government Gazette Extraordinary notification issued vide No. 115-2020/Ext. dated 18.08.2020 along with copy of notification of Haryana Government, Health Department No. 17/52/2018-3 HB-II dated 18.08.2020.
6. Considered and approved the Report of the Committee duly constituted by the Vice-Chancellor for wide deliberation to decide the modalities regarding grant of permanent affiliation to affiliated colleges as under:
  1. The college should have its own building.
  2. The college should have minimum 70% (Regular/Extension Lecturer) of teaching staff of the total sanctioned strength/workload in the last three years.
  3. The college should have adequate funding for Library Books, Laboratory equipments and chemicals and sports etc. in the last three years.

Further, the terms and conditions approved by the Executive Council on 06.07.2016 vide Resolution No. 49 (Annexure – I, Pages 37 to 40) were amended as under:

**Clause 3:** Deleted

**Clause 6:** The College shall pay an application fee of Rs. 1,00,000/- alongwith application.

**Clause 7:** Deleted.

**Clause 12:** The College has to pay a fee of Rs. 1,00,000/- (Rupees One Lakh) for UG Courses and Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand) for PG Courses for permanent affiliation plus any other fee prescribed by the University from time to time.

Dr. Anju Manocha, Nominee of the Director Higher Education, Haryana pointed out that before grant of permanent affiliation by the University, permanent NOC will also be required from the State Govt. and compliance to the deficiencies pointed out by the inspection committee should be ensured by the College. Further, the D.H.E. also required that all fees and dues be paid by the college concerned and the information in this regard be sent to the office of D.H.E. by 31<sup>st</sup> March positively, by the college.

The house further resolved to modify the terms and conditions of permanent affiliation and circulation thereof accordingly.

7. Noted the action taken by the Vice Chancellor under section 11(6) of the University Act 2003 for grant of provisional affiliation to start new Course of Bachelor of Library and Information Sciences with an intake of 20 students in M.P. College (for Women), Mandi Dabwali, Distt. Sirsa w.e.f. the Academic Session 2021-22 under Self Finance Scheme (SFS) subject to fulfillment of the deficiencies as pointed out by the Inspection Committee.
8. Noted the action taken by the Vice Chancellor under section 11(6) of the University Act 2003 for grant of provisional affiliation to start new Courses of M.A. (Music Vocal), M.A. Political Science, M.A. History and P.G. Diploma in Yoga with an intake of 40 students (one unit) in each course in M.M.P.G College, Fatehabad w.e.f. the Academic Session 2021-22 under Self Finance Scheme (SFS) subject to fulfillment of the deficiencies as pointed out by the Inspection Committee.

- iii) Resolved to increase the sumptuary allowance to the Principals of affiliated colleges to Rs.5000/- per month.
- iv) Resolved to increase the amount of imprest to the Chairpersons of the UTDs, Dean, USGS and Principal, University College from Rs.1000/- to Rs. 5000/-.
- v) Resolved to increase the limit for purchase of any item without quotation from Rs. 500/- to Rs. 2000/- in the University.

**Sub: Guidelines for grant of Permanent Affiliation to Govt., Govt. Aided and Self-Financing degree Colleges.**

It is to inform you that the Executive Council of Chaudhary Devi Lal University, Sirsa in its meeting held on 06/07/2016, vide Resolution No. 40 has approved the following rules/guidelines for grant of permanent affiliation to Govt. aided and Self-Financing degree Colleges:

**Govt. Degree Colleges:**

- i) On the receipt of request of the college/society an Inspection Committee constituted by the University for the Conversion of provisional affiliation into permanent affiliation to assess the human resources, postal and administrative/academic/physical infrastructure. The recommendations of inspection committee and the inspection report are submitted for consideration of the Vice-Chancellor and if accepted, the case is placed before the Executive Council for consideration. After approval of Executive Council, the College is required to deposit the prescribed permanent affiliation fee of Rs. 1,00,000/-
- ii) The case regarding conversion of provisional affiliation into permanent affiliation can be considered only when the college fulfils all the conditions i.e. 100% should be fulfilled by the college and no further conditions should be imposed by the Inspection Committee in its report.

**Non Govt.-Aided and Self Financing Degree Colleges:**

Guidelines regarding conversion of Temporary/Provisional affiliation into permanent affiliation of colleges (Non Govt.-Aided and Self Financing Degree Colleges) affiliated to Chaudhary Devi Lal University, Sirsa w.e.f. 2016-17

1. NAAC Accreditation is mandatory for granting permanent affiliation to the applicant Degree College.
2. The College which intends to get permanent affiliation shall apply to the University any time after completing five years of its provisional affiliation.
3. The College shall have completed construction of building and all infrastructure/facilities as stipulated in the regulations.
4. The College shall have at least 80% of required regular teaching or teaching/technical staff on roll continuously for the last five years on UGC/State Govt./CDLU pay scales as per norms duly approved by the University.
5. The College shall have a duly Constituted College council as per the norms.
6. The College shall pay an application fee of Rs. 50,000/- along with the application.

P.T.O.

7. The College must fulfill 80% of the requirements in terms of Academic & Physical Infrastructure & other Facilities/Amenities continuously for the last three years
8. The applicant College shall submit NOC for permanent affiliation from State Govt. in case of SFS Degree Colleges
9. The College shall introduce biometric system of attendance of staff to the satisfaction of the Inspection Committee constituted by the University
10. The College has neither any pending dues/fine/fee penalty etc. payable to the University nor any pending enquiry against it at the University/State Government level at the time of submission of application for permanent affiliation.
11. The courses running in the Colleges for which 3 batch have passed out in case of U.G. Degree courses and 2 batches have passed out for P.G. Degree courses be eligible for permanent affiliation.
12. The College has to pay a fee of Rs. 50,000/- (Rs. Fifty thousand) for U.G. Courses and Rs. 75,000/- (Rs. Seventy five thousand) per P.G. Degree courses for permanent affiliation fee plus any other fee prescribed by the University from time to time.
13. The permanent affiliation, if granted, shall be reviewed after one year on the recommendations of the Inspection Committee constituted for this purpose.
14. The permanent affiliation granted to the college may also be withdrawn even earlier if the college fails to comply with the University's instructions/directions guidelines or is found guilty of any malpractice.
