- 1. Post Graduate Diploma should be started from academic session 2022-23.
- 2. The Chairperson, Deptt. of Energy and Environmental Sciences will be the Nodal Officer of this Programme.
- 3. This diploma will be offered by the department of Energy and Environment Sciences and Public Administration jointly.
- 4. The classes of this PG Diploma will be run in the Department of Energy and Environmental Sciences. A classroom with necessary infrastructure should be arranged/provided for running the Classes of PG Diploma.
- 5. The syllabus of PG Diploma available on the UGC website may be adopted and be got approved from the Academic Council by Nodal Officer without PGBOS&R and Faculty as a number of departments are involved.
- 6. The teachers will be deputed by the concerned Chairpersons i.e. Departments of Energy and Environmental Sciences, Geography, Public Administration, Business Administration and Economics to teach the students of PG Diploma.
- 7. The Panel of Examiners will be submitted by the concerned teachers who will teach the students of PG Diploma through their Chairperson to the Nodal Officer.
- 8. The PG Diploma be started with sanctioned intake of 40 students and the eligibility for admission in this PG diploma will be Graduate in any discipline.
- 9. A total fee of Rs. 20,000/- (Rs. Twenty Thousand) be charged from each student of PG Diploma for both the semesters.
