Subject: Adoption of Government e-Marketplace (GeM) by the State - Amendments-II for effective and accelerated implementation.

1. The State Government vide its Order No.2/2/2016-41B-II dated 21.06.2021 had provided instructions related to adoption of Govt. eMarketplace (GeM) by the State. The upper financial outlay of upto Rs. 1 Crore for making purchase on the GeM have been inviting attention of the State Government for its effective and accelerated implementation. The matter has been considered and it has been decided that the upper financial outlay for procuring Goods/Stores/Services by all the Govt. Departments/Govt. Agencies of the State will be upto Rs.5 Crores.
2. Accordingly, the following amendments/substitutions are made in Order No.2/2/2016-41B-II dated 21.06.2021:-
