Introduction :

In order to encourage meritorious students towards science education and to support them for continuation of their science education up to higher level, this office had started a scholarship scheme w.e.f. 2009-10 for the Under Graduate B.Sc. (General) and Post Graduate students opting for basic science subjects viz Physics, Chemistry, Botany, Zoology, Mathematics and Geology. Every year 100 students each of B.Sc. - 1st year and M.Sc. (Previous) are selected on merit basis.

Last Date : 16 October 2015

The details of the scheme are as under:-

Eligibility:

A) For Under Graduate / B.Sc. (General) students:

** Students taking admission in B.Sc. General (Medical or Non-Medical) -1st year in the colleges / universities located within Haryana.

** Students taking B.Sc. (Non-Medical) course must have chosen any two subjects out of Physics, Chemistry, Mathematics and Geology.

** Students taking B.Sc. (Medical) course must have chosen any two subjects out of Botany, Zoology, Chemistry / Geology.

** Only those students would be eligible who have obtained minimum 85% marks or equivalent grade in 10+2 class.

** The institution/school from where the 10+2 examination has been passed should be situated in Haryana/Chandigarh. The students passing their 10+2 from outside Haryana should have to produce the Domicile / Resident certificate along with the application.

B) For Post Graduate / M.Sc. students:

** Students taking admission in M.Sc. (Previous) in any one of the basic science subjects out of Physics, Chemistry, Mathematics, Botany, Zoology and Geology in the colleges / universities located within Haryana.

** Only those students would be eligible who have obtained minimum 75% marks or equivalent grade in B.Sc. (or BA in case of M.Sc. Mathematics).

** The institution/college from where the B.Sc. / B.A. examination has been passed should be situated in Haryana/Chandigarh. The students passing their B.Sc. / B.A. from outside Haryana should have to produce the Domicile / Resident certificate along with the application.

Amount Of Scholarships :

A) For Under Graduate / B.Sc. (General) students:

** The amount of scholarship for the selected students studying in B.Sc. General Courses will be Rs 4000/- per month plus contingency stipend of Rs. 4000/- once in a year.

Sponsored Links:

** The scholarships will be provided to the students once selected during all the three years (in six installments for all six semesters) of the B.Sc. course subject to the maintenance of terms and conditions of the schemes.

** The first installment of Rs. 28000/- (Rs. 4000/- p.m. for first semester plus Rs. 4000/- annual contingency stipend) is released on the basis of selection and

thereafter every installment is released on the basis of performance of the student in previous semester i.e. 2nd installment of Rs. 24000/- on the basis of performance in 1st Semester and 3rd installment on the basis of performance of 2nd Semester and likewise.

B) For Post Graduate / M.Sc. students:

** The amount of scholarship for the selected students studying in M.Sc. courses will be Rs 6000/- per month plus contingency stipend of Rs. 5000/- once in a year.

** The scholarships will be provided to the students once selected during both years (in four installments for all four semesters) of the M.Sc. course subject to the maintenance of terms and conditions of the schemes.

** The first installment of Rs. 41000/- (Rs. 6000/- p.m. for first semester plus Rs. 5000/- annual contingency stipend) is released on the basis of selection and thereafter every installment is released on the basis of performance of the student in previous semester i.e. 2nd installment of Rs. 36000/- on the basis of performance in 1st Semester and 3rd installment on the basis of performance of 2nd Semester and likewise.

Terms & Conditions :

** This scholarship will be given to the students studying science in Under Graduate / Post Graduate classes in recognized Colleges / Universities located within Haryana.

** Only regular students will be eligible to apply for this scholarship. The students studying privately or through correspondence / distance mode or in unrecognized institutions will not be eligible for this scholarship.

** Candidates having Compartment / Re-appear in qualifying examination will not be considered for selection for this scholarship.

** The selected students have to maintain at least 60% marks and 75% attendance throughout (in every semester) for continuation of this scholarship. The principal of the concerned institute should have to furnish a certificate regarding the attendance of the student concerned, for the year / semester for which the scholarship is to be released.

** In case of re-appear or below 60% marks or below 75% attendance in any of the semester, the future installments of scholarships of the candidate will be withheld / discontinued. Candidates clearing the re-appear in supplementary examinations will not be considered for continuation of scholarships.

** The students should not be involved in any type of indiscipline or unfair means.

** This scheme does not restrict the students from availing the benefits of any other scholarship scheme / fee concessions given by any other organization / institution.

** There is no limit of family income for availing benefits of this scholarship scheme.

** Attested photocopies of all the certificates from 10th onwards will have to be attached with the application.

** While finalizing the merit list, if two or more students acquire same marks / rank in the merit list as per the selection criteria of this scheme, then all such students will be awarded the scholarship.

The application in the prescribed Performa should reach this office up to the closing date. The applications received after the closing date will not be entertained. The office will not be responsible for postal delay or any administrative delay. Therefore, it may be ensured that the applications should reach in this office on or before the closing date.

**GUIDELINES FOR POST GRADUATE MERIT SCHOLARSHIP SCHEME FOR
UNIVERSITY RANK HOLDERS AT UNDER GRADUATE LEVEL**

1. INTRODUCTION

Higher Education has had played a very vital role in the history of nation building all over the world. It is amply clear that no rise in general standards of living and culture is possible without strengthening the higher education system in the country. It obviously calls for a multipronged strategy. There is a need to modernize our higher education system, and equally important to continuously attract young and talented students to pursue higher education. It is being increasingly observed that the brighter lot is not pursuing Post-Graduate education in our institutions of higher learning.

To emerge as a powerful nation, there is an urgent need to bring in talented boys and girls in the field of Post-Graduate education by way of providing them good incentives in the form of scholarships. The UGC, therefore, introduced a Post-Graduate Merit Scholarship Scheme for University undergraduate rank holders.

The scholarship may be tenable for a period of two years to enable the rank holders of each university at undergraduate level to pursue their Master's Degree. All universities/degree awarding institutions would be required to issue rank certificates to the toppers of the university in B.A., B.Sc., and B.Com.

The purpose of this scheme is to attract talent for pursuing post graduate studies besides strengthening the basic subjects at Undergraduate level. The awardees, under this scheme, can pursue their Postgraduate programme in any area of specialization in any institution of higher learning in the country.

2. OBJECTIVES OF THE SCHEME

The objectives of the scheme are:

- 2.1. To promote and nurture talent;
- 2.2. To reward meritorious students with outstanding performance at the Under graduate level for pursuing postgraduate studies;
- 2.3. To promote study in basic courses at undergraduate level. Professional courses are not covered under the scheme;
- 2.4. To build up academic excellence at postgraduate level across the colleges and universities in the country.

3. TARGET GROUP

- 3.1 The First and Second Rank holders at undergraduate level and admitted in any Postgraduate Course would be awarded the scholarship. The students will have to submit the proof of their merit position at undergraduate level as well as their admission in postgraduate courses.
- 3.2 The scholarship would, however, be subjected to securing a minimum of sixty percent marks at undergraduate level.
- 3.3 The scheme is applicable to such students who have taken admission in regular, full-time Master's Degree course in any recognized university, deemed university, private university, autonomous college or a post graduate college.

4. ELIGIBILITY

- 4.1 The scholarship is available to the student for first PG Degree only. Age limit for the students is 30 years at the time of admission in PG course.
- 4.2 Distance mode of education will not be considered under the scheme.
- 4.3 The Undergraduate courses from following streams have been identified for the award of scholarships:
1. Life Sciences 2. Physical Sciences 3. Chemical Sciences 4. Earth Sciences 5. Mathematical Sciences 6. Social Sciences 7. Commerce 8. Languages
- 4.4 Before forwarding applications students/Universities may ensure that application satisfy all norms as per guidelines.
- 4.5 The first and second rank holders (Not position holders) would be considered from Universities/ Institutions and non-affiliated/ autonomous colleges according to the number of students who have appeared in the examination at undergraduate level as per following table.

6.1 The candidates fulfilling the eligibility conditions are required to apply online through www.ugc.ac.in/urh against the advertisement to be published by the UGC once in a year through advertisement in leading newspaper and Employment News after obtaining admission in first year Post Graduate course in a recognized University/Institution/College.

6.2 The results of selection will be declared on UGC website.

6.3 Awardees would be required to download their award letter from the online portal by logging in with the registration id and Date of birth in the event of their selection.

7. AADHAAR SEEDING

The Ministry of Human Resource Development, Government of India vide its letter D.O. No. 18-7/2013-U1A dated 10th June, 2016 has instructed the University Grants Commission that from the financial year 2016-17 onwards the Aadhaar will be used as an identifier for disbursement of all Government subsidies/Scholarships/Fellowships which are to be disbursed directly into the beneficiary's account. Accordingly, Aadhaar will be used as an Identifier for release of grant under the scheme.

8. NATURE OF ASSISTANCE AVAILABLE UNDER THE SCHEME

Amount of fellowship: Rs.3.100/- p.m for a period of two years only (10 months in the year) i.e. full duration of a PG course. No other additional grant will be payable in lieu of hostel charges and medical charges etc.

9. PROCEDURE FOR RELEASE OF GRANTS BY UGC

9.1 The fellowship amount shall be disbursed through UGC designated agency into the bank account of the awardee directly with effect from the date of joining of the candidate in the first year of Post graduate course as certified by the host institution in the joining report. The list of designated branches of UGC identified agency is available on the UGC portal i.e. www.ugc.ac.in.

9.2 The awardee is required to approach the designated branch along with a Copy of the Award Letter and Joining Report with photograph, address and contact number in the prescribed proforma Annexure-I.

9.3 The awardee is also required to submit the following documents to the designated branch of the UGC designated Bank at the stipulated period interval.

9.3.1 At the end of every three months the awardee shall submit a 'Continuation Certificate' in the prescribed proforma. **Annexure-II**. This will make the awardee eligible to draw the fellowship for the next three months.

9.3.2 After completion of one year of the award of fellowship, the concerned awardee shall submit and present his/her Progress Report in the proforma prescribed by the UGC as given in **Annexure-III**.

NOTE: The approved Agency may verify the genuineness of records before disbursement of funds.

10. PROCEDURE FOR MONITORING

10.1 The progress of the candidate shall be monitored by the head of the department. The candidate is required to submit a yearly progress report duly signed by the Head of the Department and Registrar of the University or Head of the Institution or Principal of the College to the designated bank branch. The scholarship shall stop after the last academic year of the Post graduate programme.

10.2 Any student who discontinues the studies without prior approval of the UGC will have to refund the whole amount through e-mode (RTGS/NEFT) directly to UGC account.

10.3 No extension is permissible beyond two years.

10.4 The student who is awarded Post-Graduate Scholarship for University Rank Holders will not be debarred from accepting any other scholarships.

10.5 The student availing this scheme will submit a certificate/mark sheet of completion of Post Graduate course duly signed by the Head of the department.

11. CANCELLATION OF SCHOLARSHIP

The UGC may terminate the scholarship of any student in any of the following cases:

11.1 Misconduct of the awardee, if any, reported by the University/ Institution.

11.2 Unsatisfactory progress report (i.e. if the candidate scores less than 60% marks in the first year of Master's programme).

11.3 Candidates being found ineligible at a later date shall face the penal action and will also be liable to refund the entire Scholarship amount paid.

Guidelines of Promotion of Science Education (POSE) Scholarship Scheme for Basic & Natural Science Students for the year 2017-18

1. **Introduction**

In order to encourage meritorious students towards science education and to support them for continuation of their science education up to higher level, this office provides scholarship to the 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. courses and 2-year M.Sc. course students opting for basic & natural science subjects viz (1) Physics, (2) Chemistry, (3) Mathematics, (4) Biology, (5) Statistics, (6) Geology (7) Astrophysics, (8) Astronomy, (9) Electronics, (10) Botany, (11) Zoology, (12) Bio-chemistry, (13) Anthropology, (14) Microbiology, (15) Geophysics, (16) Geochemistry, (17) Atmospheric Sciences & (18) Oceanic Sciences. The details of the scheme are as under.

2. **Admissibility of Scholarship**

The scholarships are limited only to the students who have taken admission during the year 2017 in any of the following courses: -

- (i) 3-year B.Sc. program in Basis & Natural Science / 4-year BS or 5-year integrated M.Sc./M.S. program in Basic & Natural Sciences at IIT, IISc, IISER, NISER, DAE-CBS or in any college/university in India.
- (ii) 2-year M.Sc. program in Basic & Natural Sciences.

The Scheme in its current format does not include courses in engineering, medicine, technology and other professional or technical courses.

3. **Eligibility**

- (i) For 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. in basic & natural science subjects, the students should have passed class X and XII Board examination from a school situated in Haryana with minimum 85% marks for Haryana Board schools and 90% marks for other boards like CBSE, ICSE etc. in 12th class. There shall be no cut off for admission in National Institutions like IIT, IISER, NISER, DAB-CBS, IISc etc.
- (ii) For 2-year M.Sc. in basic & natural science subjects, the student should have passed X, XII and B.Sc./B.A. (B.A. for M.Sc. Mathematics) from school/college/university situated in Haryana with minimum 75% marks in B.Sc./B.A. class.

4. Number of Scholarship

- (i) 3-year B.Sc./4-year BS/5-year Integrated M.Sc./M.S. courses - 150
(ii) 2-year M.Sc. course - 50

Chairman, EC has the right to select a student from a discipline/in case the said discipline is not represented.

In case of Tie, preference will be given as under: -

- Girls students will be preferred
- Preference to language score (better of English/Hindi) in 12th class board exam.

5. Amount of Scholarships

- Rs. 4,000/- P.M. for 3-year B.Sc. course.
- Rs. 6,000/- P.M. for 2-year M.Sc. course.
- If the students take admission in 4-year B.S. or 5-year integrated M.Sc./M.S. then the amount of scholarship during 1st, 2nd & 3rd year will be Rs. 4,000/- P.M. and during 4th & 5th year Rs. 6,000/- P.M.

6. Research Mentorship

The selected students will get mentorship grant (*one time*) of Rs. 12,000/- in 3-year B.Sc. program, Rs. 17,000/- in 4-year B.S. program, Rs. 22,000/- in 5-year integrated M.Sc. program and Rs. 10,000/- in 2-year M.Sc. program.

To avail the mentorship grant, the scholars are required to do project work under a Professor/Research Supervisor (Mentor) during vacation period, in any recognized Universities or Institutes or Research Laboratories/ Centres of their choice (preferably outside their parent institutions) either in India or abroad. For students doing a project in India, the expenses related to travel, accommodation and consumable expenses are reimbursed to the student within the mentorship grant. Please note that no food expenses are covered by this grant, as the students receive scholarship during this period. Students at 4th or 5th year of the Scholarship are allowed to carry our research project in any Institute/ University/ Laboratory abroad by utilizing the Mentorship Grant. If the sponsoring institute pays any stipend or travel grant, only the difference between the support received from all sources put together and actual expenditure will be reimbursed from the Mentorship Grant.

The Mentorship Grant shall be reimbursed directly to the Scholar to carry out research work/project. After completion of the project work at the Institute or University or Research Laboratory (either in India or abroad) under a Professor/Research Supervisor (Mentor), the candidate should submit the following documents to the HSCST for reimbursement of the Mentorship Grant.

- (i) A letter issued by the Professor/Research Supervisor and Head of Institution where the scholar is enrolled for the project. Duration of the project i.e. date of commencement and date of completion must be mentioned in the certificate.
- (ii) A report outlining the objectives and results of his/her research work/project.
- (iii) Brief details of the expenditure i.e. travel, accommodation, consumable etc. duly countersigned by the Head /Principal /Registrar/ Director of the College/University/Institute of the concerned institute.

7. **Merit List / Selection Criteria**

- (a) For 3-year B.Sc. or 4-year BS or 5-year integrated M.Sc./M.S. Courses merit list will be prepared based on average percentage score obtained in class 12th board examination in English/Hindi (better of the two) and best of three out of Physics, Chemistry, Mathematics and Biology.
(i.e. Total of 4 subjects/Maximum marks in 4 subjects = %age)

Note:

- i) First priority will be accorded to the students admitted in National institutes like IIT, IISER, NISER, DAE-CBS, IISc. Remaining scholarships will be given to others on merit.
- (i) Students who studied class 11 & 12 in a rural area school will be given additional 3% weightage, subject to maximum of 100%. Rural area school will be regarded as those schools which are within the jurisdiction of a Gram Panchayat.
- ii) The students who have passed their 11th & 12th class from **rural area elite schools will not be given additional weightage of 3%**. 'Elite' schools are defined to be schools, where tuition fees and other charges payable exceed Rs. One lakh per year.
- iii) Additional weightage would be added to the average percentage score obtained by the candidate for determining *inter se* merit. (for example: if a student got 90% marks in 12th class board exam and he/she has passed 11th & 12th class from a non-elite rural area school his/her marks, then will be considered as 93%)

- iv) The students claiming the benefit of rural area must submit the rural area school certificate duly signed by the Principal of the school and concerned BDPO.
- (b) For 2-year M.Sc. the merit list will be prepared on the basis of average percentage marks of B.Sc./B.A. course in three years.
- 8. POSE Scholarship shall be regulated with the following Guidelines**
- (i) An advertisement in the newspapers will be published for inviting online applications through web portal <http://www.haryana.gov.in/EFormsOnlineModule> or Atal Seva Kendra (AKS) situated at different locations in Haryana for award of scholarship.
- (ii) The applications received through online mode will only be entertained. The applications received by other mode will not be considered.
- (iii) Don't submit more than one application. Please ensure that the aspects of the application are correct before submitting. No claims shall be entertained in case of incomplete or non-submitted application.
- (iv) The applications received online will be scrutinized and a tentative merit list will be prepared as per the criteria of the scheme.
- (v) Upon selection, each scholar eligible to receive scholarship shall receive intimation through e-mail. Copy of the mail will be sent to the concerned institution.
- (vi) All offers made initially shall be 'Provisional'. This shall be confirmed based on the verification of original documents by this office or by the concerned institute where the student is studying. The selected students have to submit the certificate of subjects/courses pursued in the 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. & 2-year M.Sc. courses. The selected students have to submit a certificate that he/she is not availing any other scholarship along with POSE scholarship. The certificate is to be countersigned by the head/principal/registrar of the college / university / institute. The student will submit the proof of enrolment certificate duly certified from the Head /Principal / Registrar / Director of the College / University / Institute.
- (vii) Any change or re-admission to another College/ University/ Academic Institute within the same academic year is acceptable, provided the scholar pursues subjects out of identified 18 nos. subject(s). The Offer would stand invalid in case this change or re-admission occurs in the next academic year and thereon, or subject(s) pursued is/ are beyond the 18 identified subjects. In

such a case, there will be no scope for restoration of the offer and no communication would be made separately to Scholar.

- (viii) Scholars are advised to submit their self attested semester Mark-sheets on-time, preferably within 1 month of announcement of semester results to facilitate the payment of scholarship. Provisional or Internet copy of the Mark-sheets will not be considered.
- (ix) The Scholarships are paid to the scholars' on the basis of semester performance. The Scholarship is paid on the basis of following:
- The selected students have to maintain at least 60% marks. In case of SGPA/SPI or any other index awarded by the university, the conversion would be done as per university approved formula. In case such university formula is not available the percentage will be derived by scaling down the SGPA by 10%. For example the SGPA is 6/10, the equivalent percentage would be taken as $6/10 \times 0.9 = 54\%$.
 - The scholarship will be paid to the students for all the twelve months in a year starting from the month in which the admission is taken. It will be from July (admission year) to June (next year).
 - The scholarship will be released to the students in two half yearly installments semester wise. First installment will be released on selection, the 2nd on the basis of performance of 1st Semester, 3rd on the basis of performance of 2nd semester and so on.
 - The scholarships will be disbursed directly to the students in their bank accounts through online (NEFT / RTGS) transfer. All the students while applying shall have to open their accounts in the banks having Electronic Transfer / ECS facility and furnish the bank details like Name of bank, branch address, IFSC code and account number in the application format for online transfer (RTGS / NEFT) of scholarship. The student may ensure that their bank account number should be linked with Aadhar Number.
 - The subsequent installments of scholarship will be released only after receipt of the performance report/DMC of the students from the Head/Principal/Registrar/Director of the College/University/Institute where the student is studying.

9. Terms & Conditions

- (i) The students selected under this scheme will not be entitled for any other scholarship.
- (ii) Candidates having Compartment / Re-appear in semester examination will not be considered for further installment of scholarship.
- (iii) In case of re-appear or below 60% marks in any of the semester, the future installments of scholarships of the candidate will be withheld / discontinued. Candidates clearing the re-appear in supplementary examinations will not be considered for continuation of scholarships.
- (iv) This scholarship will be given to the students studying basic & natural science in the identified 18 subjects.
- (v) Only regular students will be eligible to apply for this scholarship. The students studying privately or through correspondence / distance mode or in unrecognized institutions will not be eligible for this scholarship.
- (vi) The students should not be involved in any type of indiscipline or unfair means.
- (vii) There is no limit of family income for availing benefits of this scholarship scheme.
- (viii) Self Attested photocopies of all the certificates from 10th onwards will have to be uploaded with the application.
- (ix) HSCST will have the right to increase or decrease the number of scholarship.
- (x) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of HSCST.
- (xi) In case of any confusion/dispute decision of Secretary, Executive Committee HSCST will be final.
- (xii) All correspondence in respect of POSE scholarship may be made in the name of Secretary, Executive Committee, Haryana State Council for Science & Technology, Bays No. 35-38, Sector 2, Panchkula. Guidelines of Promotion of Science Education (POSE)
Scholarship Scheme for the year 2019-20

1. Introduction

In order to encourage meritorious students towards science education and to support them for continuation of their science education up to higher level, Haryana State Council for Science & Technology provides scholarship to the meritorious students of 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. courses and 2-year M.Sc. course students opting for basic & natural science subjects viz (1) Physics, (2) Chemistry, (3) Mathematics, (4) Biology, (5) Statistics, (6) Geology (7) Astrophysics, (8) Astronomy, (9) Electronics, (10) Botany, (11) Zoology, (12) Bio-chemistry, (13) Anthropology, (14) Microbiology, (15) Geophysics, (16) Geochemistry, (17) Atmospheric Sciences & (18) Oceanic Sciences. The details of the scheme are as under.

2. Admissibility of Scholarship

The scholarships are limited only to the students who have taken admission during the year 2019 in any of the following courses: -

- (i) 3-year B.Sc./ 4-year BS or 5-year integrated M.Sc./M.S. program in Basic & Natural Sciences at IIT, IISc, IISER, NISER, DAE-CBS or in any college/university in India.
- (ii) 2-year M.Sc. program in Basic & Natural Sciences.
 - Under basic & natural science 18 subjects mentioned above will be considered.
 - The Scheme in its current format does not include courses in engineering, medicine, technology and other professional or technical courses.

3. Eligibility

1. For 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. in basic & natural science subjects, the students should have passed class X and XII Board examination from a school situated in Haryana with minimum 85% marks for Haryana Board School and 90% marks for other boards like CBSE/ICSE etc. in 12th class.
2. For 2-year M.Sc. in basic & natural science subjects, the student should have passed X, XII and B.Sc./B.A. (B.A. for M.Sc. Mathematics) from school/college/university situated in Haryana with minimum 75% marks in B.Sc./B.A. class.



4. Number of Scholarship

- (i) 3-year B.Sc./4-year BS/5-year Integrated M.Sc./M.S. courses - 150
 (ii) 2-year M.Sc. course - 50

Chairman, EC has the right to select a student from a discipline in case the said discipline is not represented.

In case of tie preference will be given as under:-

- (a) Girl students will be preferred.
 (b) Preference to language score better of (English/Hindi) in 12th class board.
 (c) Student younger in age will be preferred.

5. Amount of Scholarships

- (i) Rs. 4,000/- P.M. for 3-year B.Sc. course.
 (ii) Rs. 6,000/- P.M. for 2-year M.Sc. course.
 (iii) If the students take admission in 4-year B.S. or 5-year integrated M.Sc./M.S. then the amount of scholarship during 1st, 2nd & 3rd year will be Rs. 4,000/- P.M. and during 4th & 5th year Rs. 6,000/- P.M.

6. Merit List / Selection Criteria

a) For 3-year B.Sc. or 4-year BS or 5-year integrated M.Sc./M.S. Courses

Merit list will be prepared based on average percentage score obtained in class 12th board examination in English/Hindi (better of the two) and best of three out of Physics, Chemistry, Mathematics and Biology (i.e. Total of four subjects divided by maximum marks in four subjects = %age).

Note:

- i) First priority will be accorded to the students admitted in national institutes i.e. IIT, IISER, NISER, DAE-CBS and IISc. Remaining scholarships will be given to the others on merit.
- ii) Students who studied 11th & 12th class in a rural area school will be given additional 3% weightage, subject to maximum of 100%. Rural area school will be regarded as those schools which are within the jurisdiction of the Gram Panchayat.
- iii) The students who have passed their 11th & 12th class from rural area elite schools will not be given additional weightage of 3%. 'Elite' schools are defined to be schools, where tuition fees and other charges payable exceed Rs. One lakh per year.
- iv) Additional weightage would be added to the average percentage score obtained by the student for determining *inter se* merit (for example if a student got 90% marks in 12th class board exam and he/she has passed 11th and 12th class from a non-elite rural area school than his/her marks will be considered as 93%).
- v) The students claiming the benefit of rural area must submit the rural area school certificate of passing 11th and 12th class from the rural area school duly signed by the Principal of the school, Sarpanch of

the the village panchayat from where the 11 and 12 class passed and
concerned BOPO.

b) For 2 year M.Sc.

The merit list will be prepared on the basis of average percentage marks of B.Sc./B.A. course in three years.

7. Research Mentorship

The selected students will get mentorship grant (*one time*) of Rs. 12,000/- in 3-year B.Sc. program, Rs. 17,000/- in 4-year B.S. program, Rs. 22,000/- in 5-year integrated M.Sc. program and Rs. 10,000/- in 2-year M.Sc. program.

To avail the mentorship grant, the scholars are required to do project work under a Professor/Research Supervisor (*Mentor*) during vacation period, in any recognized Universities or Institutes or Research Laboratories/ Centres of their choice (preferably outside their parent institutions) either in India or abroad. For students doing a project in India, the expenses related to travel, accommodation and consumable expenses are reimbursed to the student within the mentorship grant. Please note that no food expenses are covered by this grant, as the students receive scholarship during this period. Students at 4th or 5th year of the Scholarship are allowed to carry our research project in any Institute/ University/ Laboratory abroad by utilizing the Mentorship Grant. If the sponsoring institute pays any stipend or travel grant, only the difference between the support received from all sources put together and actual expenditure will be reimbursed from the Mentorship Grant.

The Mentorship Grant shall be reimbursed directly to the Scholar to carry out research work/project. After completion of the project work at the Institute or University or Research Laboratory (either in India or abroad) under a Professor/Research Supervisor (*Mentor*), the candidate should submit the following documents to the HSCST for reimbursement of the Mentorship Grant.

- (i) A letter issued by the Professor/Research Supervisor/Head of Institution where the scholar is enrolled for the project indicating the duration of the project i.e. date of commencement and date of completion.
- (ii) A report outlining the objectives and results of his/her research work/project.

- (iii) Brief details of the expenditure i.e. travel, accommodation, consumable etc. duly countersigned by the Head /Principal/ Registrar/ Teacher of the College/University/Institute of the concerned institute.
- (iv) Detail of the funds received from any other department/institute for the said research work/ project.

8. Continuation of Scholarship

- (i) Students are advised to submit their self attested semester Mark-sheets through their institutions immediately after the declaration of result, preferably within 1 month of announcement of semester results to facilitate the payment of scholarship. Provisional or Internet copy of the Mark-sheets will not be considered.
- (ii) The Scholarships are paid to the students on the basis of performance in the semester examination. For continuation of scholarship the selected students have to maintain at least 60% marks in each semester. In case of SGPA/SPI or any other index awarded by the university, the conversion would be done as per university approved formula. In case such university formula is not available the percentage will be derived by scaling down the SGPA/SPI by 10%. For example the SGPA/SPI is 6 on 10 point scale, the equivalent percentage would be taken as 54%.
- (iii) In case the institute/university is awarding SGPA/SPI or any index, the students are required to send the institute/university approved conversion formula from SGPA/SPI to equivalent %age.
- (iv) The scholarship will be paid to the students for all the twelve months in a year starting from the month in which the admission is taken. It will be from July (admission year) to June (next year).
- (v) The scholarship will be released to the students in two half yearly installments semester wise. First installment will be released on selection, the 2nd on the basis of performance of 1st Semester, 3rd on the basis of performance of 2nd semester and so on.
- (vi) Candidates having Compartment / Re-appear in semester examination will not be considered for further installment of scholarship.
- (vii) In case of re-appear or below 60% marks in any of the semester, the future installments of scholarships of the students will be discontinued.

Candidates clearing the re-appear in supplementary examinations will not be considered for continuation of scholarships.

9. POSE Scholarship shall be regulated with the following terms and conditions.
- (i) *The students selected under this scheme will not be entitled for any other scholarship.*
 - (ii) The applications received through online mode will only be entertained. The applications received by other mode will not be considered.
 - (iii) Don't submit more than one application. Please ensure that all the columns of the application are correct before submitting. No claims shall be entertained in case of incomplete or non-submitted application.
 - (iv) The applications received online will be scrutinized and a merit list will be prepared as per the criteria of the scheme.
 - (v) All offers made initially shall be 'Provisional'. This shall be confirmed based on the verification of original documents by this office or by the concerned institute where the student is studying. The selected students have to submit the certificate of subjects/courses pursued in the 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. & 2-year M.Sc. courses. The selected students have to submit a certificate that he/she is not availing any other scholarship along with POSE scholarship. The certificate is to be countersigned by the head/principal/registrar of the college / university / institute. The student will submit the proof of enrolment certificate duly certified from the Head /Principal / Registrar / Director of the College / University / Institute.
 - (vi) Any change or re-admission to another College/ University/ Academic Institute within the same academic year is acceptable, provided the scholar pursues subjects out of identified 18 nos. subject(s). The Offer would stand invalid in case this change or re-admission occurs in the next academic year and thereon, or subject(s) pursued is/ are beyond the 18 identified subjects. In such a case, there will be no scope for restoration of the offer and no communication would be made separately to Scholar.
 - (vii) The scholarships will be disbursed directly to the students in their bank accounts through online (NEFT / RTGS). All the students while applying shall

have to open their accounts in the banks having Electronic Transfer / ECS facility and furnish the bank details like Name of bank, branch address, IFSC code and account number in the application format for online transfer (RTGS / NEFT) of scholarship. The student may ensure that their bank account number should be linked with Aadhar Number.

- (viii) This scholarship will be given to the students studying basic & natural science in the identified 18 subjects.
- (ix) Only regular students will be eligible to apply for this scholarship. The students studying privately or through correspondence / distance mode or in unrecognized institutions will not be eligible for this scholarship.
- (x) The students should not be involved in any type of indiscipline or unfair means.
- (xi) There is no limit of family income for availing benefits of this scholarship scheme.
- (xii) Self Attested photocopies of all the certificates from 10th onwards will have to be uploaded with the application.
- (xiii) HSCST will have the right to increase or decrease the number of scholarship.
- (xiv) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of HSCST.
- (xv) In case of any confusion/dispute decision of Secretary, Executive Committee HSCST will be final.
- (xvi) Sanction in respect of the shortlisted students will be issued by this office after verification of original documents, submission of the proof of enrolment certificate and other relevant papers duly certified from the Head /Principal /Registrar /Director of the College /University / Institute.

**GUIDELINES FOR POST GRADUATE INDIRA GANDHI SCHOLARSHIP FOR
SINGLE GIRL CHILD**

1. INTRODUCTION

It is observed that number of girls as against boys in certain states is declining which is a matter of great concern. The females are even forced to give birth to male child. In such circumstances education of women needs to be used and effective means for their empowerment and education will prepare them to have a control over their lives. The mindset which militates against the girl child could not keep pace with economic progress and literacy. The Government of India declared elementary education as a basic human right of every child. The Union Government of India has taken various steps to uplift the status of women by implementing various schemes including free education for girls. In order to achieve and promote girls education, UGC has introduced a Post Graduate Indira Gandhi Scholarship for Single Girl Child with an aim to compensate direct costs of girl education to all levels especially for such girls who happen to be the only girl child in their family.

2. OBJECTIVES

The objectives of the proposed scheme are:

- a) To support post graduate education of single girl child in postgraduate courses only.
- b) To recognize the value of observance of small family norm.

3. TARGETGROUP

- Girl students who are admitted in the first year of PG courses in the following Universities / Colleges and happen to be the only girl child in the family:
- Universities/Institutions/Colleges included under section 2(f) & and 12(B) of UGC Act.
- Deemed to be Universities included under Section 3 of the UGC Act, 1956 and eligible to receive grants-in-aid from UGC. Those Deemed Universities which do not receive funds from the Central/ State Government are not eligible institutions under the scheme.
- Universities/Institutions/College funded by Central/State Government.
- Institutes of National Importance.
- Girl students without having any brother or the girl student who are twin daughters/ fraternal daughter may also apply for scholarship under the aforesaid scheme. In a family if one son and one daughter is available then girl child will not be considered for scholarship under the scheme.

4 ELIGIBILITY

- Slots : 3000
- **Age limit:** Girl students up to the age of 30 years at the time of admission in first year of PG courses are eligible.
- The scheme is applicable to such single girl child who has taken admission in regular, full-time first year Masters Degree course in any designated university or a post graduate college.
- **Admission to PG Course in Distance education mode is not covered under the scheme.**

5 NATURE OF ASSISTANCE AVAILABLE UNDER THE SCHEME

Amount of fellowship: Rs.36,200/- p.a. for a period of two years only i.e. full duration of a PG course. **No other additional grant will be payable in lieu of hostel charges and medical charges etc.**

6 PROCEDURE FOR APPLYING

- The candidates fulfilling the eligibility conditions are required to apply online on National Scholarship Portal after initiation of application process and notice to be published on UGC website.
- The host institution where the candidate is studying is required to verify the online application.
- It is expected from the institutions where student has taken admission in the first year PG course, no tuition fees will be charged by the institute from girl students to pursue PG degree course in Universities/Colleges/Institutions

7 AADHAAR SEEDING

The Ministry of Human Resource Development, Government of India vide its letter D.O. No. 18-7/2013-U1A dated 10th June, 2016 has instructed the University Grants Commission that from the financial year 2016-17 onwards the Aadhaar will be used as an identifier for disbursement of all Government subsidies/Scholarships/Fellowships which are to be disbursed directly into the beneficiary's account. The disbursements will be governed by the Aadhaar Act, 2016.

8. PROCEDURE FOR APPLYING FOR THE SCHEME

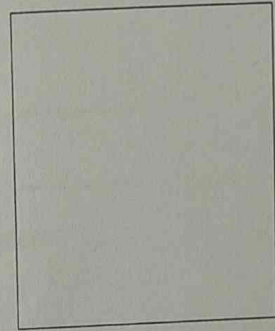

Guidelines of Promotion of Science Education (POSE)
Scholarship Scheme for the year 2020-21

1. Introduction

In order to encourage meritorious students towards science education and to support them for continuation of their science education up to higher level, Haryana State Council for Science, Innovation & Technology provides scholarship to the meritorious students of 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. courses and 2-year M.Sc. course students opting for basic & natural science subjects viz (1) Physics, (2) Chemistry, (3) Mathematics, (4) Biology, (5) Statistics, (6) Geology (7) Astrophysics, (8) Astronomy, (9) Electronics, (10) Botany, (11) Zoology, (12) Bio-chemistry, (13) Anthropology, (14) Microbiology, (15) Geophysics, (16) Geochemistry, (17) Atmospheric Sciences & (18) Oceanic Sciences. The details of the scheme are as under.

2. Admissibility of Scholarship

The scholarships are limited only to the students who have taken admission during the year 2020 in any of the following courses: -

- (i) 3-year B.Sc. / 4-year BS or 5-year integrated M.Sc./M.S. program in Basic & Natural Sciences at IIT, IISc, IISER, NISER, DAE-CBS or in any college/university in India.
- (ii) 2-year M.Sc. program in Basic & Natural Sciences.
 - Under basic & natural science 18 subjects mentioned above will be considered.
 - The Scheme in its current format does not include courses in engineering, medicine, technology and other professional or technical courses.

3. Eligibility

1. For 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. in basic & natural science subjects, the students should have passed class X and XII Board examination from a school situated in Haryana with minimum 85% marks for Haryana Board School and 90% marks for other boards like CBSE/ICSE etc. in 12th class.
2. For 2-year M.Sc. in basic & natural science subjects, the student should have passed X, XII and B.Sc./B.A. (B.A. for M.Sc. Mathematics) from school/college/university situated in Haryana with minimum 75% marks in B.Sc./B.A. class.

Note:- If a student is presently availing the POSE scholarship in B.Sc class and he or she is studying in the college/institute situated out of Haryana. If he or she applies for scholarship in M.Sc class then he or she is eligible to apply for the POSE scholarship. In this case 10th and 12th class should be passed out from the school/college situated in Haryana.

4. Number of Scholarship

- (i) 3-year B.Sc./4-year BS/5-year Integrated M.Sc./M.S. courses - 150
 (ii) 2-year M.Sc. course - 50

Chairman, EC has the right to select a student from a discipline in case the said discipline is not represented.

In case of tie preference will be given as under:-

- (a) Girl students will be preferred.
 (b) Preference to language score better of (English/Hindi) in 12th class board.
 (c) Student younger in age will be preferred.

5. Amount of Scholarships

- (i) Rs. 4,000/- P.M. for 3-year B.Sc. course.
 (ii) Rs. 6,000/- P.M. for 2-year M.Sc. course.
 (iii) If the students take admission in 4-year B.S. or 5-year integrated M.Sc./M.S. then the amount of scholarship during 1st, 2nd & 3rd year will be Rs. 4,000/- P.M. and during 4th & 5th year Rs. 6,000/- P.M.

6. Merit List / Selection Criteria

a) For 3-year B.Sc. or 4-year BS or 5-year integrated M.Sc./M.S. Courses

Merit list will be prepared based on average percentage score obtained in class 12th board examination in English/Hindi (better of the two) and best of three out of Physics, Chemistry, Mathematics and Biology (i.e. Total of four subjects divided by maximum marks in four subjects = %age).

Note:

- i) First priority will be accorded to the students admitted in national institutes i.e. IIT, IISER, NISER, DAE-CBS and IISc. Remaining scholarships will be given to the others on merit.
- ii) Students who studied 11th & 12th class in a rural area school will be given additional 3% weightage, subject to maximum of 100%. Rural area school will be regarded as those schools which are within the jurisdiction of the Gram Panchayat.
- iii) The students who have passed their 11th & 12th class from **rural area elite schools will not be given additional weightage of 3%**. 'Elite' schools are defined to be schools, where tuition fees and other charges payable exceed Rs. one lakh per year.
- iv) Additional weightage would be added to the average percentage score obtained by the student for determining *inter se* merit (for example if a student got 90% marks in 12th class board exam and

he/she has passed 11th and 12th class from a non-elite rural area school then his/her marks will be considered as 93%).

- v) The students claiming the benefit of rural area must submit the rural area school certificate of passing 11th and 12th class from the rural area school duly signed by the Principal of the school, Sarpanch of the village panchayat from where 11th and 12th class passed and concerned BDPO.

b) For 2-year M.Sc.

The merit list will be prepared on the basis of average percentage marks of B.Sc./B.A. course in three years.

7. Research Mentorship

The selected students will get mentorship grant (*one time*) of Rs. 12,000/- in 3-year B.Sc. program, Rs. 17,000/- in 4-year B.S. program, Rs. 22,000/- in 5-year integrated M.Sc. program and Rs. 10,000/- in 2-year M.Sc. program.

To avail the mentorship grant, the scholars are required to do project work under a Professor/Research Supervisor (Mentor) during their study in their parent institution or in any recognized Universities or Institutes or Research Laboratories/ Centres of their choice (preferably outside their parent institutions) either in India or abroad. For students doing a project in India, the expenses related to travel, accommodation and consumable expenses are reimbursed to the student within the mentorship grant. Please note that no food expenses are covered by this grant, as the students receive scholarship during this period. Students at 4th or 5th year of the Scholarship are allowed to carry out research project in any Institute/ University/ Laboratory abroad by utilizing the Mentorship Grant. If the sponsoring institute pays any stipend or travel grant, only the difference between the support received from all sources put together and actual expenditure will be reimbursed from the Mentorship Grant.

The Mentorship Grant shall be reimbursed directly to the Scholar to carry out research work/project. After completion of the project work the candidate should submit the following documents to the HSCSIT for reimbursement of the Mentorship Grant.

- (i) A letter issued by the Professor/Research Supervisor/Head of Institution where the scholar is enrolled for the project indicating the duration of the project i.e. date of commencement and date of completion.
- (ii) A report outlining the objectives and results of his/her research work/project.
- (iii) Brief details of the expenditure i.e. travel, accommodation, consumable etc. duly countersigned by the Head /Principal/ Registrar/ Teacher of the College/University/Institute of the concerned institute.

- (iv) Detail of the funds received from any other department/institute for the said research work/ project.

8. Continuation of Scholarship

- (i) Students are advised to submit their self attested semester Mark-sheets through their institutions immediately after the declaration of result, preferably within 1 month of announcement of semester results to facilitate the payment of scholarship. Provisional or Internet copy of the Mark-sheets will not be considered.
- (ii) The Scholarships are awarded to the students on the basis of performance in the semester examination. For continuation of scholarship the selected students have to maintain at least 60% marks in each semester. In case of SGPA/SPI or any other index awarded by the university, the conversion would be done as per university approved formula. In case such university formula is not available the percentage will be derived by scaling down the SGPA/SPI by 10%. For example the SGPA/SPI is 6 on 10 point scale, the equivalent percentage would be taken as 54%.
- (iii) In case the institute/university is awarding SGPA/SPI or any index, the students are required to send the institute/university approved conversion formula from SGPA/SPI to equivalent %age.
- (iv) The scholarship will be paid to the students for all the twelve months in a year starting from the month in which the admission is taken. It will be from July (admission year) to June (next year).
- (v) The scholarship will be released to the students in two half yearly installments semester wise. First installment will be released on selection, the 2nd on the basis of performance of 1st Semester, 3rd on the basis of performance of 2nd semester and so on.
- (vi) Candidates having Compartment / Re-appear in semester examination will not be considered for further installment of scholarship.
- (vii) In case of re-appear or below 60% marks in any of the semester, the future installments of scholarships of the students will be discontinued. Candidates clearing the re-appear in supplementary examinations will not be considered for continuation of scholarships.

9. POSE Scholarship shall be regulated with the following terms and conditions.

- (i) *The students selected under this scheme will not be entitled for any other scholarship.*
- (ii) The applications received through online mode will only be entertained. The applications received by other mode will not be considered.

This shall be confirmed based on the verification of original documents by this office or by the concerned institute where the student is studying. The selected students have to submit the certificate of subjects/courses pursued in the 3-year B.Sc./4-year BS/5-year integrated M.Sc./M.S. & 2-year M.Sc. courses. The selected students have to submit a certificate that he/she is not availing any other scholarship along with POSE scholarship. The certificate is to be countersigned by the head/principal/registrar of the college / university / institute. The student will submit the proof of enrolment certificate duly certified from the Head /Principal / Registrar / Director of the College / University / Institute.
- (vi) Any change or re-admission to another College/ University/ Academic Institute within the same academic year is acceptable, provided the scholar pursues subjects out of identified 18 nos. subject(s). The Offer would stand invalid in case this change or re-admission occurs in the next academic year and thereon, or subject(s) pursued is/ are beyond the 18 identified subjects. In such a case, there will be no scope for restoration of the offer and no communication would be made separately to Scholar.
- (vii) The scholarships will be disbursed directly to the students in their bank accounts through online (NEFT / RTGS). All the students while applying shall have to open their accounts in the banks having Electronic Transfer / ECS facility and furnish the bank details like Name of bank, branch address, IFSC code and account number in the application format for online transfer (RTGS / NEFT) of scholarship. The student may ensure that their bank account number should be linked with Aadhar Number.
- (viii) This scholarship will be given to the students studying basic & natural science in the identified 18 subjects.
- (ix) Only regular students will be eligible to apply for this scholarship. The students studying privately or through correspondence / distance mode or in unrecognized institutions will not be eligible for this scholarship.
- (x) The students should not be involved in any type of indiscipline or unfair means.
- (xi) There is no limit of family income for availing benefits of this scholarship scheme.
- (xii) Self Attested photocopies of all the certificates from 10th onwards will have to be uploaded with the application.
- (xiii) HSCSIT will have the right to increase or decrease the number of scholarship.
- (xiv) If a student is found to have obtained a scholarship by false statement, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of HSCSIT.

- (xv) In case of any confusion/dispute decision of Secretary, Executive Committee HSCSIT will be final.
- (xvi) Sanction in respect of the shortlisted students will be issued by this office after verification of original documents, submission of the proof of enrolment certificate and other relevant papers duly certified from the Head /Principal /Registrar /Director of the College /University / Institute.

**GUIDELINES FOR POST GRADUATE INDIRA GANDHI SCHOLARSHIP FOR
SINGLE GIRL CHILD**

1. INTRODUCTION

It is observed that number of girls as against boys in certain states is declining which is a matter of great concern. The females are even forced to give birth to male child. In such circumstances education of women needs to be used and effective means for their empowerment and education will prepare them to have a control over their lives. The mindset which militates against the girl child could not keep pace with economic progress and literacy. The Government of India declared elementary education as a basic human right of every child. The Union Government of India has taken various steps to uplift the status of women by implementing various schemes including free education for girls. In order to achieve and promote girls education, UGC has introduced a Post Graduate Indira Gandhi Scholarship for Single Girl Child with an aim to compensate direct costs of girl education to all levels especially for such girls who happen to be the only girl child in their family.

2. OBJECTIVES

The objectives of the proposed scheme are:

- a) To support post graduate education of single girl child in postgraduate courses only.
- b) To recognize the value of observance of small family norm.

3. TARGETGROUP

- Girl students who are admitted in the first year of PG courses in the following Universities / Colleges and happen to be the only girl child in the family:
- Universities/Institutions/Colleges included under section 2(f) & and 12(B) of UGC Act.
- Deemed to be Universities included under Section 3 of the UGC Act, 1956 and eligible to receive grants-in-aid from UGC. Those Deemed Universities which do not receive funds from the Central/ State Government are not eligible institutions under the scheme.
- Universities/Institutions/College funded by Central/State Government.
- Institutes of National Importance.
- Girl students without having any brother or the girl student who are twin daughters/ fraternal daughter may also apply for scholarship under the aforesaid scheme. In a family if one son and one daughter is available then girl child will not be considered for scholarship under the scheme.

4 ELIGIBILITY

- **Slots** : 3000
- **Age limit**: Girl students up to the age of 30 years at the time of admission in first year of PG courses are eligible.

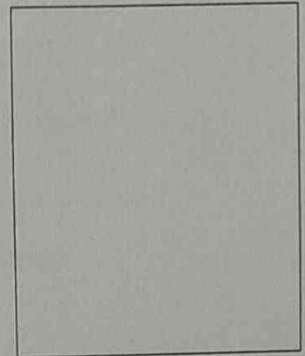


