3. Considered the action taken by the Vice-Chancellor on 8.10.2008 under Section 11(6) of Chaudhary Devi Lal University, Sirsa Act 2003 in adopting the Ordinance "Award of grace marks" of Maharshi Dayanand University, Rohtak.
